

MoneyGram Domestic and Outbound transfers **Remittances Promotion**

PROMOTION

- MoneyGram will be sponsoring a MoneyGram Domestic and Outbound transfers Promotion.
- Remittance Promotion from the 14th April to 31st May, 2025
- The MoneyGram Domestic and Outbound transfers Promotion is open to customers who use MoneyGram to send money overseas or within Trinidad and Tobago during the promotion period.
- Each valid money transfer transaction is entered into a database, which will be used as the pool of qualified submission from which winners will be randomly selected.
Selected winners will be based on one/each sent transaction.
- **Each weekly winner will be disqualified from other weekly draws.**
- **Each weekly winner will receive CASH TT\$500.00**
- **5 Weekly winners - 6 weeks of promotion (5 winners per week)**
- **One grand prize of TT\$2,500.00 will be drawn at the end of the six week promotion**
- There will be a total of Thirty (30) weekly winners and one (1) Grand Prize winner, which be weekly announced on the official Facebook and Instagram pages of MoneyGramtt or Massyremittances.
